Chartered Practicing Accountants (CPA) Australia, on July 16, 2018 fully accredited the Bachelor of Commerce in Accounting programme offered by The University of Fiji.

CPA Australia is a prestigious and one of the largest professional accounting bodies in the world.

Speaking at the Press Conference held on July 30, 2018, the Acting Vice-Chancellor (AVC), Professor Narendra Reddy, highlighted that universities were about education and value of education.

He stated that when programmes were accredited, it brought in value to the University's programmes.

He further commented that there were four types of accreditation for universities: national accreditation, accreditation from regulatory agency, international accreditation and accreditation from professional bodies such as other universities.

AVC also said that accreditation was not the final part of a journey; it was the beginning of a journey.

He said that the journey included bettering the university programmes and facilities. An accreditation from CPA Australia means that the Bachelor of Accounting programme at UniFiji is fully recognized by them and is on par with Australian and New Zealand tertiary accounting qualifications.

The accreditation adds value to the Accounting programme at the University and shows that the accounting offerings at Uni-Fiji are second to none in the country.

The accreditation also enhances credibility of the Accounting programme and those enrolled therein, demonstrating that the qualification is recognized internationally.

The accreditation depicts that the programme structure, the course contents, delivery and the resources are of a high standard.

Accreditations are for limited time; CPA Australia would renew the accreditation in 2022 while FIA renews accreditation every 3 years.

Accounting is an ever-changing field with new ideas and ways to account constantly on the move in this complex world.

Professor Reddy stated that UniFiji endeavored to operate in an open and conducive manner.

He mentioned that should a student or a staff has any concern, then they were to register the same with relevant authority for consideration and action if found to be valid.

Explaining the discipline aspect, he commented that to keep a harmonious learning environment discipline amongst staff and students remained a key priority at UniFiji. Discipline was also the key factor for success.

Hence, he advised all to exercise discipline in all areas of engagement as staff and students of UniFiji.

Moreover, Professor Reddy encouraged students to attend all lectures and tutorials.

He also advised staff not to cancel classes without proper authorization and in case of cancelled classes, to reschedule the classes at the earliest possible time.

He also explained the regulations gov-

erning the University and advised staff and students to follow all regulations as regulations were meant to safeguard everyone's interest.

Professor Reddy advised staff and stuents to refrain from bullying.

"As adults both staff and students need to be wary of unpleasant outcomes of bulling. Bulling comes in many forms and one of those is usage of unpleasant and unprofessional language," he stated.

He summed by saying that the University will not tolerate any forms of bullying.

Addressing Climate Change and Global Warming Issues in **Schools**

Climate change is a reality for the Pacific Island nations as they constantly face the aftermath of climate change on a daily basis. There is significant impact on ecosystems, economies and communities.

With this in mind, Dr. Wahab Ali of the School of Humanities and Arts completed a research project titled "Green leadership as an emerging Style for addressing Climate Change and Global Warming issues in Schools". The paper attempts to investigate the concept of green leadership towards a greener environment through addressing issues of climate change and global warming. The paper is aimed at eliciting views of principals about climate concepts and their opinions about green leadership.

Speaking about Green Leadership, Dr. Ali stated that a green leader needed to have the ability to change and adapt quickly-with a future smart eye on what was possible. He added that green leadership was ideal for current and emerging principals and teachers. Green leadership would make principals aware of these austerities and would enable them to transmit the knowledge to their subordinates and in way it trickles down to the students.

"The threat of climate change needs to be taken very seriously and awareness need not be confined to scientists only. It is necessary to bring this knowledge to students, teachers, parents and the community at large. This is where the principals need to be in the picture, as change agents. Principals can create more awareness and actions through their students and teachers by entailing them in climate change awareness programs," he stressed.

Ms. Manpreet Kaur, Ms. Sanjaleen Prasad and Mr. Salesh Kumar from the Department of Language, Literature and Communication (LLC) at the School of Humanities and Arts attended a 2-Day Conference by the Institute of Education (IOE).

The Conference titled "Vaka Pasifiki Education Conference" (VPEC) was hosted at The University of the South Pacific (USP) on July 5 and 6, 2018.

Ms. Kaur presented a joint paper with Mr. Avitesh Kumar (UniFiji student and school teacher), titled "Probing the Place of English Language in Fiji Secondary Schools in the Present Day – from English Facilitators Perspective". The paper examined the status of the English language in Secondary Schools in Fiji from the English teachers' perspective. Mr. Kumar and Ms. Prasad also presented a joint paper titled "Teacher Beliefs on Second Language Acquisition (SLA)". The paper investigated teacher beliefs about second language acquisition (SLA).

Both the papers were well received by the audience and generated discussions on the learning and teaching of English Language in secondary schools. The papers were later presented at UniFiji on July 13, 2018 and were attended by School of Humanities and Arts staff and students.

The Conference aimed to bring into focus the notion of rethinking Pacific education for resilient and healthy communities. VPEC provided an opportunity for sharing of ideas, presentation of research and best practice, and discussion of issues relevant to teacher education, educational policy and practice, and teaching and learning in Oceania.

The Conference was attended by more than 300 participants with 113 papers presented on the theme "It takes an island and an ocean: Rethinking Pacific Education for resilient, healthy communities".

JDP School of Law Staff Attend Mediation Seminar

Academic staff and students of the Justice Devendra Pathik School of Law (JDP SoL) attended the Fiji Women Lawyers Association (FWLA) Seminar on Mediation at the Judges Common Room, Government Buildings on Monday July 16, 2018.

JDP SoL Dean, Professor Shaista Shameem together with law staff, Ms. Fariyal Varsha Bano and Ms. Evelyn Chuang were among the various senior legal practitioners and judges from around Fiji who attended the high level seminar

The panel comprised Mr. George Lim of the Singapore Mediation Centre, Ms. Jenny Seato of the Fiji Mediation Centre and Justice Kamal Kumar of the High Court of Fiji.

The seminar informed legal practitioners of the benefits of mediation process and outcomes instead of the adversarial approach to legal work.

Bema Open Forum

The Justice Devendra Pathik School of Law (JDP SoL) hosted its first Bema Open Forum for staff and students on Wednesday, July 25, 2018. The Fijian Competition and Consumer Commission (FCCC) staff Mr. Nilesh Chand, Senior Research and Policy Officer and Ms. Lusia Ting spoke on the topic "Consumer Protection in Fiji".

Mr. Chand and Ms. Ting spoke on the Commission's successful cases, examples of products wrongfully priced, examples of advertisements that were misleading and also baiting of the general public.

Mr. Chand in his response to questions on increase of fuel prices said that the matter was regulated by FCCC unlike previous years where there were no regulations or ceiling of profit margins on LPG (cooking

Professor Shameem said that attending the workshop had future benefits to the JDP SoL programme.

"Mediation training is part of JDP SoL's continuing legal education and will assist in alternative dispute resolution courses in our programme. Mediation also is a very important aspect of organisational management nowadays and also has the potential for sustainably resolving disputes university-wide," she explained.

"Like any organisation, the University will have internal disagreements but mediation, which involves consultation, will normally resolve disputes amicably. In our traditional Fijian societies we tend to solve disputes quite well internally and it is encouraging to see alternative dispute resolution entering the formal legal field. It is the modern and sustainable way to bring greater cohesion among people", she said.

"It is now widely recognised that the high-handed top-down approach to organisational governance can create disputes within organisations. We need a different way to resolve such disputes, and this leads to greater productivity" Professor Shameem added.

The UniFiji JDP SoL was thanked by the President of the FWLA and Chairperson of the Fiji Mediation Centre for attending the Seminar. The President of the FWLA said the Association appreciated the support of the JDP SoL at their events and seminars.

While explaining the rent freeze currently in Fiji, Mr. Chand mentioned that land-lords should not have a change in tenancy agreement to increase rent because there was a freeze in place. He commented that matters concerning Value Added Tax (VAT) would be managed by Fiji Revenue and Customs Service (FRCS) and taxi permits by Land Transport Authority (LTA).

The Dean of JDP SoL, Professor Shaista Shameem, emphasized and reiterated that there would be relevant films screened during future Bema sessions that would cover law, human rights, media freedom, and so forth. The Bema sessions were open not only for law students and staff, but all other Schools as well.

The University of Fiji's Justice Devendra Pathik School of Law (JDP SoL) staff and students took part in the Pacific Law and Culture Conference at the University of Canterbury in New Zealand from July 2-4, 2018. The theme of the 2018 conference was" Voices of the Pacific in a Globalised World" and the conference was aimed towards increasing an understanding of Pacific legal issues and towards strengthening relationships between Pacific legal scholars and students.

Mr. Ronald Singh, Senior Lecturer in Law, presented a paper on "Legal and Cultural Challenges to Wealth Creation in Fiji'. In his paper, Mr. Singh advanced the argument 'that legislation and indigenous cultural disposition conspire to hinder indigenous wealth creation and maximization, legislation is either nonexistent, or restrict property rights, while the use of cultural elements for individual economic gains is tabooed'. Moreover, Mr. Shivendra Nath, presented a paper on "Impediments of the International Criminal Court and the Pacific". The paper focused on the principles and the policies of ICC, challenges in prosecution against the backdrop of prosecution in African States, its constant struggle with State sovereignty and the proposal towards encouraging cooperation in the Pacific Island states that is consistent with International Law.

Mr. Waisele Tabuya chaired a session on Customary Law. Three students, Joseph Rao, Elizabeth Rao and Nayna Kasturi took part in the moot event. The team was coordinated by Ms. Varsha Bano. Though the students did not qualify for the finals, moot team still had an opportunity to interact with participants from other attending Universities and build on their networks.

The JDP SoL hopes that International mooting would become an annual event in future as it gives a profile to the University, the Law School, International exposure to staff and students and greater initiatives for future mooters.

Speaking at the book launch, Professor Singh highlighted that the book was meant for the general public who wish to advance their knowledge in the area of Renewable Energy.

He further stated that the book covered all areas of renewable energy (RE), commencing from biomass energy and hydropower and proceeding to wind, solar and geothermal energy before ending with an overview of ocean energy.

The last two chapters considered how the technologies were actually being implemented today and their roles in climate change mitigation and poverty allevia-

Speaking at the launch, the Acting Vice-Chancellor, Professor Narendra Reddy commented that universities were about learning, research and publication. He said that the book was a welcome addition to the area of renewable energy.

"With climate change clearly visible around the world, a book as such would help mitigate some impacts of climate change. The book is also particularly helpful because it will help alleviate poverty," he stressed.

He further commented that the best part of the book was that it was in plain English because not everyone was at Professorial level in the world. By doing so, the reach of the book in the public had expanded.

The book is published by IOP Publishing under their Concise Physics programme in conjunction with Morgan & Claypool (UK).

गिरमिट काल में जागृति by: SALESHNI DEVI (Part 2)

यादि कछ गिरमिटिया विवाह करते भी थे. तो उनपर गुलामी वाले नियम लागू होते थे। 'जैसे कि औरत किसी को बेची जा सकती थी, युवा आरतों को मालिक लोग रखैल बनाकर रखेते थे और उनका भरपर यौनशोषण करते थे।

गिरमिटियों को केवल जीवित रहने लायक भोजन दिए जाते थे। इन्हें शिक्षा मनोरंजन आदि मूलभूत जरूरतों से वंचित रखा जाता था।

ये लोग बारह से अठारह घंटों तक प्रतिदिन कमरतोड मेहनत करते थे। पाँच वर्षा की गिरमिट बहुत मुश्किल से कटता था।कुछ लोग आत्म-हत्या करके मृत्यु के शिकार हो जाते थे। जब अत्याचार सीमा से बाहर हो जाती थी , तब श्रमिक भी उन पर प्रहार करबैठते थे।

जा भारतीय सरदार ओवरसियरों के पक्ष लेकर श्रमिकों को परेशान करते थे, उनपर अत्याचार करते थे। महिलाओं को दूर भेज देते थे, बहुत सारा काम देकर और रात होने पर औरतों पर अत्याचार, मारपीट, यहाँ तक की अंग्रेज लोग बलात्कार भी करते थे।

गिरमिट की कछ शर्तें भी थी। काम करने का समय, काम का दिन, वेतन और गिरमिट की आखिरी वर्ष। गुलाम पैसा चुकाने पर भी गुलामी से मक्त नहीं हो सकता था।

गिरमिटियों के साथ केवल इतनी बाध्यता थी, कि वे पाँच सालों बाद छूट सकते थे।

१६१७ में गिरमिट प्रथा खत्म हो गया और कुछ लोग जकड़ से खुल गए थे। पाँच वर्षकी गुलामी समाप्त हुई। पच्चीस हजार भारतीय भारत वापस लौंट गए थे, शेष ने फीजी को ही अपना देश स्वीकार कर लिया था। जकड से खुल गए थे, लेकिन कुछ लोगों के पास वापस भारत लैटने के लिए पैंसे भी नहीं थे।

गिरिमट काल में संस्कृति और धर्म में बहुत बड़ा जगृति हुई।

हमारे पर्वजों ने संस्कृतिदारा धर्म में जगित रखने के लिए, गाँव मैं मंडली द्वारा सर्त्संग करते थे, रामायण पाठ करते थे, भजन कीर्तन और राम लिला भी करते थे।

हर दृष्टि से अपने कार्य और प्रयास से जीवन में सुरव- शांति पाना ही भारतीय संस्कृति और धर्म का परम उद्येश्य था।

रामायण पढ़ने से कई काम में भी जगृति हुआ।

कई माता-पिता अपने बच्चों के नाम भी रामायण के पात्रा के तरह रखने लगे, जैसिक लक्षमण, राम राज, राम भरत और राम औतार।

विवाह के क्षेत्र में भी जगति आने लगी। शादी विवाह भी होने लगी। शादी के दिन, शादी के तिथि और लगन सब राशिफल, सभी एक पंडित, जन्म कुंडली देख कर निर्णय लिया करता था।

पोशाक पहनेने का तरीका भी बहुत अलग था।
