School of Law Programmes The Certificate in the Fundamentals of Law provides a pathway into the LLB programme. It is designed at the Year 13 level and will prepare students for future legal studies by focusing on law-specific subjects. It provides a solid foundation in subjects such as introduction to law, legal research, English for legal purposes and law and technologies by using alternative teaching and learning methodologies to make learning easier, practical and more appropriate for students' competencies.

Bachelor of Laws

Year 1

First year law students learn about the development of the Fijian legal systems within a historical framework. Topics such as Sources of Law and the different types of law help students understand how law can be categorised and efficiently implemented. Student's understanding of the roles and powers vested within the 3 arms of the government namely; Judiciary, Executive and the Legislature help enhance a general understanding of the "rule of law" and its application to the society.

Upon completion of all first year courses students ought to have a general understanding of the judicial system and the roles and powers of the law enforcement agencies. Students can also decode the intention behind legislation and critically understand how law really influences the society. If one cannot understand the societal behavioral pattern or reaction, it would be difficult to understand how people react in a certain manner and perform efficiently as lawyers. Basically, laws are meant for the betterment of the society and so a better and basic understanding is crucial from our first year law students .

LLB

Year 2

The Year 2 courses are aimed at building and consolidating on the foundation provided by year one courses contributing to assist in producing students who have a solid foundation in substantive and procedural aspects of the law. The students, at the end of Year 2 are expected to have knowledge and understanding of the legal principles or concepts which are developed further with the assistance of lecturers, to the extent that students are able to critically analyse legal principles and apply these in a variety of scenarios. Students are assisted to use case law and trace the growth and development of legal principles from their origins to date and to know and understand the exceptions and or limitations to the principles. They are taught to critically examine legal principles, including the questions of criminal and civil liability, and the the role of statutes or legislations in reforming the common law in these areas. The students are expected to understand the origins, nature and character of the relevant laws; have knowledge and understanding of the relationship between common law and statute; identify, and demonstrate knowledge and understanding of the causes of action, or charges and the defences in civil and criminal actions. The students are expected to know and understand the role of the Courts and the approaches and strategies adopted by judges, including the consideration of Policy matters, when making decisions.

Year 3

Year 3 at law school is dynamic in its own right! From enduring law school courses such as Family law, Company law and Succession law, Year 3 law grounds students into the foundation of practice or professional vocations in legal studies, depending on individual students' aspirations. The program also includes specialised areas such as mastering concepts of Consumer Competition law as well Alternative Dispute Resolution techniques to being enthralled in the theories driving the law in Jurisprudence. As is the case with all the different years, Year 3 includes rigorous legal training through very accommodating lecture formats with an effective balance between theory and practical elements.

With the option of two elective courses offered in years 3 and 4, students will be able to choose a course of their liking from course offerings for that respective term in anticipation of a broad area of work/practice to their liking. This includes stimulating courses such as Intellectual Property law, Medical law and Ethics, Law and Religion, Environmental law, Military law and others. For this year of law studies, students will be expected to pursue individual research and study on top of lecture content and participate actively throughout the various courses to reap the best rewards.

Year 4

In the final year of their LLB programme are target to examines rules and principles which govern the presentation and proof of facts and information in Civil and Criminal Court Proceedings. It considers in detail the forms and types of evidence, the onus and standard of proof, rules of proof, corroboration, admissibility, discretion, the effect of non-compliance with rules of evidence. Further, the courses will train individuals to deal with witnesses and hearsay evidence, and prepare oral and written submissions within the pre-trial and trial process. One is able to critically identify legal issues and evaluate assumptions, implications and practical consequences of alternative perspectives. They learn to be able to conduct trials according to the rules of evidence (per court rules and common law); and are able to utilize legal research skills effectively and synthesize rules of evidence coherently .It is envisaged one will benefit exponentially in effectively advocating in all matters in any legal proceeding; as effective Legal Researchers and Writers represent clients in disputes and legal proceedings to ensure natural justice.

Having successfully passed this course as Year IV students will qualify for GDLP studies

Graduate Diploma in Legal Practice

The Graduate Diploma in Legal Practice (GDLP) is an intensive programme that prepares students for admission to practice law in Fiji. The programme thus bridges the gap between the academic study of law and legal practice in the profession and is the foundation upon which you can launch a successful legal career. The course is designed to equip the students with knowledge and practical skills so that they can become a competent practitioner. The GDLP programme was approved by the Board of Legal Education. Students are expected to work in collaboration and co-operation with the GDLP module instructors and fellow students throughout the programme. Students are required to approach the GDLP course with the level of professionalism expected in the legal environment.

The programme includes 10 modules and satisfies the practical training requirement for admission under the Legal Practitioners Act 2009. It is offered twice a year in Samabula Campus subject to the number of enrolled students. This is an intensive full-time programme over an approximate period of 22–24 weeks.

GDLP

"An important development and progression from a Bachelor of Laws, the LLM is offered under two modes: 1) by Coursework; and 2) by Coursework and Thesis. The Master of Laws allows students to specialise in particular areas of law. For example, students can decide to gain expertise in tax, commercial, employment, environmental and criminal law, amongst many other fields.For the LLM by Coursework mode, students must complete 2 compulsory courses and 6 electives. The LLM by Coursework and Thesis mode encourages high quality research and requires 4 compulsory units including a Major Thesis in Law (40,000 - 60,000 words, including notes and bibliography). As an integral part of students' education at the Law School, and in preparation for practice as legal professionals, the Law School faculty expects law students to communicate effectively with others orally and in writing, as well as act with diligence.

Law students are also expected to manage time and projects responsibly, being able to master the law and analyse legal issues competently. To do this, they must collect and comprehend relevant information, identify the issues that are raised by a matter, understand the applicable legal rules, and provide coherent analysis. Finally, lawyers are entrusted to serve as guardians of the law, to support improvements in the law, and to strengthen respect for the rule of law. At the same time, UniFji is both research-led and practice-driven, aiming at bridging the gap between practice and academia. Law teachers are dedicated to their work, enthusiastic, knowledgeable and very approachable aiming to make studying at UniFji a pleasant experience".

Postgraduate Certificate in Peacekeeping

PGDPLAW

Post-Graduate Diploma In Public Law

The course is designed to assist future leaders (without prior legal qualifications) develop managerial and policy skills needed for today's public sector. It is intended to assist accountants, auditors, architects, town planners, engineers, IT professionals, and public servants. It involves the study of general principles of Judicial Review and other aspects of Administrative Law,(LawP 401), Human Rights Law, Constitution and Legal Research (LawP 400) Employment Law (LawP 402) and Alternative Dispute Resolution (LawP 403)

The program involves 4 compulsory courses and will guide professionals in addressing complex practical problems in the area of Public Administrative Law and associated matters with judgment and responsibility. Graduates will be able to offer technical advice with responsibility and accountability apart from being able to analyze and generate innovative solutions to complex 21st century challenges in the area of Public Administrative Law and related areas.

Post Graduate Diploma is offered for 12 months (2 semesters) for those wishing to study full time. Alternatively, the program can be completed on a part time basis of four years of eight semesters.

International Relations & Diplomacy

INRD

The Postgraduate International Relations & Diplomacy Programme educates students using an inter-disciplinary perspective. Students develop a critical and cutting edge understanding of international diplomacy, bilateral and multilateral relations, and regional developments in economic and political alliances, humanitarian cases, peacekeeping, human rights and more. The programme enables students to place their prior academic and/or work experiences within a diplomats, public servants, political analysts, military professionals, journalists, NGO workers, and others with analytical skills to examine complex international and regional issues.

There are multiple qualifications that lead up to the Master of International Relations & Diplomacy. Students can decide how far they would like to progress thought the programme so long as the requirements are met. Additionally, the law school is pleased to offer the Doctor of Philosophy (PhD) in International Relations and Diplomacy as well.

- Progress and performance tracking, including gradebooks and reporting that capture data from attendance, assessments and polls housed within the platform to provide insights into student achievement and participation."

- Refer students to the University Counsellor or other services when required;
- Provide short written reports to the Dean, School of Law or any student who has been assisted; and
- Keep proper records on all students on the Academic Advisor's list.

SoL Activites

Thespian Society



The Thespian society was the result of an innovative new project undertaken by the JDP School of Law to unify legal technical competence and experience with legal values to students.

Legal plays by the Thespian Society are produced annually by the School with the aim of encouraging students to use language to best effect or learn how to memorize. The origin of the idea to produce a legal play a year came from the fact that legal students needed practice in speaking skills because litigation requires confidence and a keen appreciation of performance and theatre.

The Thespian Society deliberately chooses plays which allows students to explore certain legal values, concepts and themes. It also aims to encourage students to learn, whether through performance via producing plays or as the audience, that understanding the law is more than just acquisition of technical competence.

Moot

The JDP SoL Moot Court Competition gives students the opportunity to compete in simulated court proceedings, usually involving drafting legal documents and making oral presentations against an opposing counsel before a judge. It is perhaps the closest experience that a student can have whilst at University to appearing in court.

Mooting encourages participants to focus on practicing speech and the ability to argue the question of law. It also helps participants to build confidence in public speaking, general research and presentation skills, which are useful skills which a participant can transfer to most careers.

In the year 2018, The JDP SoL Moot team had the opportunity to travel abroad and compete at the Pacific Law and Culture Moot Competition hosted by the University of Canterbury, Christchurch. In the year 2021, JDP School of Law launched the Inter-tertiary moot competition in which our Mooters competed against the University of the South Pacific and the Fiji National University. The competition was one of the major highlights of the year 2021 and was attended and supported by many government and non-government organizations, judges, private practitioners, academics, staff and students. It was an on-going event which was run at two different divisions (junior and senior) of which our mooters won the junior division. The JDP SoL hopes to make Moot Court Competition an annual event for the School.

It lasted for 3 hours 3 7 minutes and 28 seconds with a live audience of 382 connecting online. The final phase was conducted with the support and close corroboration of the University IT department, and the unwavering support of our corporate partners and sponsors.
