The University seeks a comprehensive, scalable, secure, and cloud-ready solution that will replace its legacy systems and support the University's strategic objectives through integrated business processes, improved service delivery, enhanced reporting, and data-driven decision-making.

Functional Requirements

- Information on vendor, local and regional support capability.
- Details of product roadmap and ongoing development.
- Any additional information considered relevant to this EOI.

The University reserves the right to shortlist respondents and invite selected vendors to participate in a subsequent Request for Proposal (RFP) process, cancel the EOI process, or vary the scope of the project without assigning any reason and at its sole discretion.
